## **GENERAL TERMS AND CONDITIONS**

### **1.PERFORMANCE**

Bijoux Catering Zürich is committed to perform in the agreed event in a timely manner and to the full satisfaction of the customer. The assortment of food and beverages is to be provided in best quality.

### **2.OFFER**

Ordinarily a complimentary first offer will be provided. If the customer requests a second and more detailed offer before the event is confirmed Bijoux Catering Zürich is allowed to charge additional expenses for the generation of further offers compliant with these requests.

### **3.ORDER CONFIRMATION**

An order with Bijoux Catering Zürich is to be placed in verbally or in written form. Verbal arrangements will be confirmed in a written form by Bijoux Catering. The event shall happen as confirmed in written form and under the agreement with the terms and conditions as well as a deposit. As long as no possible discrepancies have been reported, the order confirmation is mandatory.

### **4.RENT OF MATERIAL**

The customer is only allowed to use the rented material according to the agreed, intended purpose and location. The cleaning is included in the rental fee. A remittance is to be understood in case of defects, breakage or shortage of material upon return, and a notice of expense shall be forwarded.

### **5.PAYMENT & TAXES**

Payment must be made within 10 days after receipt of the invoice. The prices exclude VAT, which is added to the final subtotal calculation.

### **6.OFFERS AND PRICES**

All prices stated in our web pages, printed products or offers in CHF are pure collection prices and, unless expressly stated otherwise, exclude the legal value of added tax..

### **7.WORKING HOURS**

For working hours to be accounted on the final price, both return and return travel as well as clean-up and cleaning on site. For events continuing after 23:00 a surcharge of 25% will be charged on the hourly rates. Miscellaneous such as decoration, transport, music will be billed according to arrangement.

## 8. STORNIERUNGEN VON ANLÄSSEN

On cancellations on up to 30 days prior to the event no fee will be applied.

In case of cancellation of events within less than 30 days, the following fees shall apply:

29-22 days	prior to the event :	30% of the agreed service final price
21-14 days	prior to the event :	50% of the agreed service final price
13-7 days	prior to the event :	80% of the agreed service final price

## 9. PAYMENTS, PRICES

9.1 Bijoux Catering shall receive payment in full amount for the services provided 10 days after the issuing of the final Invoice.

9.2 Bijoux Catering is entitled to demand a reasonable deposit. For orders over 600.00 CHF a deposit of 50% of the total amount must be paid directly upon reservation/confirmation of the service. The remaining balance shall be stated on the final Invoice mentioned above.

9.3 All prices are stated in Swiss Francs (CHF) and exclude taxes.

9.4 Bijoux Catering reserves the right to price changes and fluctuations.

## 10. NUMBER OF ATENDEES

Unless otherwise agreed upon, the final number of attendees or participants of the agreed event must be communicated no later than 14 working days prior to the event. If after this date a smaller number of attendees is reported or observed, the ordered quantities must nevertheless be charged.

## 11. VALIDITY OF THE OFFER

The validity of the present offer is of 10 days after the date of its issue.
